

SINGLE TOWNSHIP ROAD DISTRICT
BUDGET & APPROPRIATION ORDINANCE

An ordinance making appropriations to defray expenditures of the Lemont Township Road District, Cook County, Illinois for the fiscal year beginning April 1, 2018 and ending March 31, 2019.

Be it ordained by the Board of Trustees of Lemont Township Road, Cook County, Illinois

SECTION 1: That the following budget containing an estimate of revenues and expenditures is hereby adopted for the following funds:

SECTION 3: That each total is divided among the several objects and purposes specified and in particular amounts stated for each fund respectively in Section 1 constituting the total appropriations in the amount of One Million, Two Hundred Thirty-Five, Three Hundred Eighty-Three Thousand Dollars, and 30/100 (\$1,235,383.30) for the fiscal year April 1, 2018 to March 31, 2019.

SECTION 4: That Section 2 shall be and is the annual Appropriation Ordinance of this Road District, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

SECTION 5: A certified copy of the Amended Budget & Appropriation Ordinances shall be filed with County Clerk within 30 days after adoption.
