

ORDINANCE No. 2019-2020-04
TOWNSHIP
TAX LEVY ORDINANCE

An ordinance levying taxes for all town purposes for the Lemont Township, Cook County, Illinois, for the year 2019.

BE IT ORDAINED by the Board of Trustees of Lemont Township, Cook County, Illinois, as follows:

SECTION 1: That the sum of Nine Hundred, Sixty Thousand, Six Hundred Sixty –Six Dollars and Forty-Two Cents (\$960,661.42), is hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:


SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
